

St. Elias Church “Win With the Trinity 2023” Official Rules

SPONSOR: St. Elias Church “Win With the Trinity 2023” (“Fund Raiser Raffle”) is a fund raiser event sponsored by St. Elias Melkite Catholic Church (“St. Elias”), 8023 Memphis Avenue, Brooklyn, Ohio 44144. St. Elias is responsible for the delivery of the Prize (as defined below) to the winners. Clergy, employees, directors, and volunteers of St. Elias are involved in the implementation and execution of the Fund Raiser Raffle (collectively, “Fund Raiser Raffle Administrators”).

ELIGIBILITY: The Fund Raiser Raffle is open only to persons who are at least 18 years old at the time of entry and have access to a computer or smart phone capable of two-way messaging. All federal, state, and local laws apply. Valid in the United States only.

TIMING: The Fund Raiser Raffle runs from January 1, 2023 through December 31, 2023 (“Fund Raiser Raffle Period”). Fund Raiser Raffle tickets will be sold from November 6, 2022 through the Fund Raiser Raffle Period until sold out.

OFFICIAL RULES: The Fund Raiser Raffle is a fundraiser for the benefit of St. Elias, a 501(c)(3) non-profit religious organization. By purchasing a Fund Raiser Raffle ticket, you accept and agree to these Official Rules, including, but not limited to, your consent to receive communications from Fund Raiser Raffle Administrators in connection with the Fund Raiser Raffle.

One Fund Raiser Raffle ticket will be randomly selected for a Prize each day of the Fund Raiser Raffle Period. The decisions of St. Elias shall be final and binding in all respects relating to this Fund Raiser Raffle. The authorized account holder (the natural person assigned to the payment account associated with the purchase of a Fund Raiser Raffle ticket) will be deemed to be the holder of the Fund Raiser Raffle ticket (“Ticket Holder”). Any remaining unsold tickets are the property of St. Elias Church.

HOW TO PURCHASE A Fund Raiser RAFFLE TICKET: An eligible person may purchase a Fund Raiser Raffle ticket by scanning our QR code or visiting our Fund Raiser Raffle website, <https://www.steliasmelkitechurch.com> or our Facebook page at www.facebook.com/steliasmelkite. You will have the option to select your ticket number or to get a randomly selected ticket number from the remaining available ticket numbers between 000 and 999. If you choose to get a random ticket number, you must indicate how many tickets you wish to purchase. You must click “Add to cart” to select a ticket. If you choose to select your own ticket number, you must add each ticket you intend to purchase to your cart one by one. You may purchase as many tickets as you like from the remaining available tickets, however, no more than one thousand tickets will be sold. Once you have added all of your tickets to the cart, you must proceed to checkout to review your purchase. You will be charged a convenience fee, in addition to the cost of any Fund Raiser Raffle tickets you purchase. The convenience fee is \$1.03 for the first ticket you purchase, and \$0.73 for each additional ticket thereafter. You will be asked to complete your purchase through PayPal, Venmo, Pay Later, or your debit or credit card, at your option. If you use your phone to purchase a ticket, normal time, toll, connection, and usage rates, if any, charged by your service provider will apply.

PRIVACY: You will be asked to provide your billing information, which we will share with PayPal, Venmo, Pay Later, or your debit or credit card company, depending on your payment selection. We will send an email confirmation of each Fund Raiser Raffle ticket purchase to the email address provided at purchase. We will process your personal information according to our Privacy Policy. Third parties with whom we

share your personal information will process it according to their own privacy policies. We will communicate with Fund Raiser Raffle Prize Winners, as defined below, regarding Prizes. Please review our privacy policy for information about how to change your privacy preferences.

PRIZE: Each Ticket Holder whose ticket number is selected (“Prize Winner”) will be entitled to receive a monetary amount, awarded in U.S. Dollars (“Prize”), payable by a once monthly check payable for 90 days that will be mailed to the billing address you confirm via email upon notification that you are a Prize Winner. The amount of the Prize will be determined based on the date that the Prize Winner’s ticket number was selected. A \$200 Prize will be awarded to Prize Winners whose ticket numbers were selected on Easter (04/09/2023) and Christmas Day (12/25/2023). A \$100 Prize will be awarded to Prize Winners whose ticket numbers were selected on the following dates:

Prizes for all other days will amount to \$25. Prize Winners will receive an email message to the email address provided at purchase, indicating that they have been selected for a Prize and the amount of the Prize. Prize Winners will be required to: 1) respond to the email to confirm the mailing address; or 2) forward the email to a gift recipient who will then need to provide their name and mailing address to St. Elias to claim a Prize. If a Prize Winner or gift recipient does not respond to the email within 30 days, the Prize will be forfeited. If a Prize Winner forfeits a Prize, no substitution will be made except in St. Elias’s sole discretion. Each Prize Winner is responsible for all taxes and fees associated with Prize receipt and/or use. St. Elias is not responsible for lost or stolen Prizes or any delay or failure of delivery by the U.S. Postal Service.

RELEASE AND CONSENT: This Fund Raiser Raffle is subject to all federal, state, and local laws. A Ticket Holder may be disqualified from the Fund Raiser Raffle by failing to comply with each provision of these Official Rules, as determined in the sole discretion of St. Elias. Participation in the Fund Raiser Raffle is at your own risk. Any person attempting to defraud or in any way tamper with this Fund Raiser Raffle will

be ineligible to participate and may be prosecuted to the fullest extent of the law. If a technology platform, software, or hardware is incapable of running as planned for any reason beyond the control of St. Elias, St. Elias reserves the right, in its sole discretion and without obligation or prior notice, to cancel, terminate, modify, or suspend the Fund Raiser Raffle. In the event of cancellation or suspension, St. Elias shall promptly post a notice on the Fund Raiser Raffle website page to such effect. St. Elias shall not be liable for: technical failures of any kind that may limit your ability to purchase a Fund Raiser Raffle ticket or any technical malfunctions of the platform, operating system, telephone network, on-line system, computer equipment or other device, software or applications, program malfunctions or other failures, delayed device transactions or network connections that are human, mechanical, or technical in nature, or any combination thereof, including any injury or damage to your or another person's computer or device related to or resulting from participating in this Fund Raiser Raffle.

By participating in the Fund Raiser Raffle, Ticket Holder agrees for Ticket Holder and Ticket Holder's heirs, executors, and administrators (a) to be bound by these Official Rules; (b) to release and hold harmless Fund Raiser Raffle Administrators from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from such Ticket Holder's participation in the Fund Raiser Raffle and/or his/her acceptance, possession, use, or misuse of Prize or any portion thereof (including any travel related thereto); (c) to indemnify Fund Raiser Raffle Administrators from any and all liability resulting or arising from the Fund Raiser Raffle and to hereby acknowledge that Fund Raiser Raffle Administrators have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to Prize; and (d) to waive any right to claim any ambiguity or error herein or in the Fund Raiser Raffle itself, and to be bound by all decisions of St. Elias, which are binding and final.

ADDITIONAL TERMS: St. Elias reserves the right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Fund Raiser Raffle.

If for any reason the Fund Raiser Raffle is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of St. Elias or its affiliates that corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Fund Raiser Raffle, St. Elias, at its sole discretion, reserves the right to cancel, terminate, modify, or suspend the Fund Raiser Raffle and to disqualify any individual who tampers with the Fund Raiser Raffle process. St. Elias reserves the right to permanently disqualify from the Fund Raiser Raffle any person St. Elias, in its sole discretion, believes has intentionally violated these Official Rules. ANY ATTEMPT TO DELIBERATELY DAMAGE THE WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS FUND RAISER RAFFLE MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, ST. ELIAS RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEYS' FEES) TO THE FULLEST EXTENT OF THE LAW. If the Fund Raiser Raffle is cancelled for any reason before completion of the Ticket Sales Period, all tickets purchased up to the point of termination will be included in random selection for Prizes according to these Official Rules.

St. Elias's failure to enforce any term of these rules shall not constitute a waiver of that provision. In any cause of action, the Fund Raiser Raffle Administrators' liability shall be limited to \$500.00, and in no event shall the Fund Raiser Raffle Administrators be liable for attorneys' fees and/or experts' fees and costs. By participating in the Fund Raiser Raffle, each Ticket Holder waives the right to claim any

additional damages whatsoever, including, but not limited to, punitive, consequential, incidental or indirect damages (unless otherwise prohibited by law).

PUBLICITY: Except where prohibited, Prize Winners consent to St. Elias's and its agents' use of Prize Winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, including but not limited to the Internet and St. Elias's social media sites, worldwide, without further payment or consideration.

GOVERNING LAW: The Fund Raiser Raffle and the Official Rules shall be governed according to the laws of Ohio, without regard to principles of conflicts of laws. All claims, actions or suits must be brought in a court of competent jurisdiction in Cuyahoga County, Cleveland, Ohio.
